### **MAIN STREET PROJECT (MSP) ISOLATION SITE**

The Isolation Site is a dedicated site where individuals who are homeless can safely and effectively be isolated and / or quarantined consistent with public health standards.

The site provides shelter for those who have tested for COVID-19 and have nowhere to self-isolate while they wait for their results, and for those who test positive for COVID-19 but do not require hospitalization.

### **POSITION SUMMARY**

Under the general supervision of the Nurse Practitioner, the LPN/RN will demonstrate a commitment to the mission, vision and values of MSP. The LPN/RN is responsible for providing professional practical nursing services to designated clients, including independent nursing services, administration of prescribed medical treatments, collaboration and interaction within a multidisciplinary team, and participation in the coordination of client care and discharge

- Ability to apply Harm Reduction and Housing First philosophies in day to day work
- Knowledge of Indigenous culture
- The ability to speak/understand an Indigenous language considered an asset

### **ADDITIONAL REQUIREMENTS**

- Good physical and mental health
- Ability to lift – moderate to heavy effort
- First aid, CPR and NVCI
- Satisfactory criminal record check with clear vulnerable sector search
- Clear adult abuse registry check
- Valid class driver's license



**WORKING CONDITIONS**

- Fast paced environment with occasional high pressure or emergent situations
- Frequent exposure to bodily fluids; frequent interaction with a diverse population with varying addictions and mental health needs
- Frequent sitting, standing, walking, grasping, carrying and speaking; occasional reaching, bending and stooping; lifting, carrying, pushing and pulling up to 50 pounds, with assistance if needed
- May need to lift or turn clients with mobility issues
- Frequent use of computer, keyboard, copy and fax machine and cell phone
